The Canton School District Board of Education met in regular session on Monday, June 8, 2020 at 7:00 pm in the school library.

The meeting was called to order and opened with the Pledge of Allegiance.

J. Otkin moved, second by J. Skiles to approve the minutes of the regular meeting held May 11, 2020. Aye: all members

Administrative reports were given and included: Kindergarten Assessments to be held July 20 and 21, summer latchkey is underway, student material check-in was June 2nd, and plans are being made for HS Graduation to be held July 25th. Our application for Special Ed extra-ordinary cost funds has been approved in the amount of \$271,383.

Supt. Gerber informed the board that there would be no special legislative session in June. Our District "Start Well 2020" Committee has met, we plan to start the new school year on time, with the first day for students August 19th.

A special meeting of the board will be held Wednesday, June 24, 2020 at 7pm to discuss CoVid19 re-opening schedules and upcoming school activities.
