Board of Education Proceedings

The Canton School District Board of Education met in regular session on Monday, March 8, 2021 at 7:00 pm in the school library.

Members and others present: Christal Dietzenbach, Todd Gannon, Josh Otkin, Jennifer Skiles, Supt. Terry Gerber, Principals' Gabe Devitt and Russ Townsend, Asst. Principal Kent Knudson, and Business Manager Thompson.

The meeting was called to order by Vice Chair Otkin and opened with the Pledge of Allegiance.

C.Dietzenbach moved, second by T. Gannon to approve the minutes of the regular meeting held February 8, 2021. Aye: all members

No conflicts of interest were identified.

T. Gannon moved, second by J. Skiles to approve the agenda as amended. Aye: all members

T. Gannon moved, second by J. Skiles to approve the following consent agenda items: offer and accept a contract with Michelle Kippley as MS track coach in the amount of \$1,996.14; offer a contract to Melissa Anderson as elem. Para-professional for the remainder of the 20-21 school year; offer and accept contracts for 2021-22 with Kent Knudson as HS/MS Principal and with Madison Kenney-Special Ed Teacher, both to be amended upon completion of the negotiations process; accept the contracts for 2021-22 to be amended at a later date from Business Manager Nancy Thompson, K-5 Principal Gabe Devitt, Special Ed Director Sarah Richarz, Network Administrator Bob Falk, and Building and Grounds Director Darin Sehr; accept the resignation from Kaitlyn Sehr as HS assistant volleyball coach; amend the 20-21 track coach contract with Betsy Lukonen from MS track to Asst. HS track; approve the 5 year contract for bussing services with American Bus Corporation; offer and accept a contract for the remainder of the 2020-21 school year, in the amount of \$10,967.79, with Shelby VanVoorst, as Elem. Enrichment Teacher, using Covid-19 ESSER II Funds; and accept the FY21 Audit quote from Quam, Berglin and Post in the amount of \$9,400. Aye: all members

T. Gannon moved, second by J. Skiles to accept the financial statement for the month of February 2021. Aye: All members.

Administrative reports were given and included the following: Elementary activities and upcoming Smarter Balanced testing; MS/HS conferences will be March 15 and 16, and All-State Choir for this year has been cancelled; there will be no school board election this year. Scott Larson and Tharron Ockenga were unopposed for the two open positions.
