Board of Education Proceedings

The Canton School District Board of Education met in regular session on Monday, July 11, 2022 at 7:00 pm in the school library.

Board members present: Gannon, Iverson, Kappenman, Larson, Ockenga, Otkin, and Skiles. Absent: None. Administration present: Superintendent Townsend, Principal Knudson, Principal DeVitt, and Business Manager Andersen.

The meeting was called to order at 7:00 p.m. and opened with the Pledge of Allegiance.

Otkin moved, second by Skiles to approve the minutes of the regular meeting held June 13, 2022. Aye: all members.

Iverson moved, second by Gannon to approve the agenda as presented. Aye: all members.

No conflicts of interest were identified.

Skiles moved, second by Otkin to approve the following consent agenda items:

Business Manager Andersen asked the board some questions on preferences going forward.

The Oath of Office was signed and recited by returning board members Todd Gannon, Tanya Iverson, and Josh Otkin, each for a three year term.

Otkin was nominated by Skiles to be board Chair. Vote was held, Aye all members.

Otkin was elected as Chairman of the Board of Education. The meeting was turned over to the Board Chairman.

Skiles was nominated by Otkin to be board vice chair. Vote was held, Aye all members.

Skiles was elected as Vice-Chairman of the Board.

- h. Authorize Russ Townsend or his designee to close school in case of inclement weather or other emergencies

- i. Authorize Brian Andersen as custodian of all accounts and to transfer money as needed
