Board of Education Proceedings

The Canton School District Board of Education met in regular session on Monday, September 11, 2017 at 7:00 pm in the school library.

The meeting was called to order and opened with the Pledge of Allegiance.

Members and others present: Todd Gannon, Jon Gustad, Bruce Henke, Tanya Iverson, Todd Larson, and Jennifer Skiles, Supt. Gerber, Principals Townsend and Devitt, Robyn Ventura, Shelly Eich, City Manager Amanda Mack, and Business Manager Thompson.

No conflict of interest items were identified.

T. Larson moved, second by J. Skiles to approve the agenda as amended to add an open enrollment application, and the following consent agenda items: approve the minutes of the regular meeting held August 14, 2017; approve 6 open enrollment requests to attend Canton School District; approve the lane change request from Jacob Versteeg from BA to BA30; and approve the termination of the current easement on Tract 1 with the City of Canton, and approve the new easement along the north side of Tract 1 and 2 (north side of the PAC). - T. Gannon moved, second by T. Larson to accept the financial statement for the month of August, 2017. Aye: all members

Administrative reports were given and included NWEA testing and assessments are underway, we are short staffed, needing substitutes and special ed aides; math intervention and advisory lessons, and a review of 2016-17 revenues and expenses.

The District has been awarded the silver level "ALL Award" for 2016-17 from the Ass. School Boards of SD. Supt. Gerber also provided an update on the Performing Arts Center progress, and use of contingency funds.

A first reading was conducted on policy revisions to Conflict of Interest, Military Leave, and background checks.

Discussion was held regarding an abatement for the city road between the game field and the practice football field to the north.

<u>9/7/17</u> T. Gannon moved, second by J. Gustad to petition the city to vacate Verne Kennedy Drive. Aye: all members

Changes to the 2017-18 Proposed budget were reviewed with the Board. The only change was to the tax calculation for Capital Outlay due to new growth limits which were made available in August 2017.

9/8/17 Let it be resolved that the School Board of Canton School District, after duly considering the proposed budget, hereby approves and adopts the proposed budget as amended to be its annual budget for the fiscal year July 1, 2017 through June 30, 2018. The adopted Annual Budget levy requests for 2017 tax paid in 2018 as set by the state are as follows: General Fund-Ag \$1.507, Owner Occupied \$3.372, Other and Utilities \$6.978; Capital Outlay Fund dollar request \$1,800,000; Special Education Fund mil levy request \$1.461; there is no longer a Pension levy allowed; and the Bond Redemption dollar request is \$416,000. Total appropriations: General Fund \$5,996,282; Capital Outlay Fund (with Cap.Projects-PAC) \$13,622,748; Special Education Fund \$1,176,915; Food Service Fund \$311,011; and Bond Redemption Fund \$449,678. Motion by T. Larson, second by T. Gannon, aye: all members, motion carried
