

Canton School District 41-1
Board of Education Proceedings

The Canton School District Board of Education met in regular session on July 14, 2014 at 7:00 pm, in the school library.

Members and others present: Bruce Henke, Tanya Iverson, Kevin Jensen, Todd Larson, Emily Plucker, and Craig Stearns, Supt. Gerber, Principals Townsend and Devitt, AD Eric Smart, Building and Grounds Director Sehr, Business Manager Thompson, and roofing contractors.

The meeting was called to order by Chairman Stearns.

K. Jensen moved, second by E. Plucker to approve the agenda as amended, and the following consent agenda items: approve the minutes from June 9, 2014; adopt the secretary's negotiated agreement for 2014-15 and amend contracts; accept the open enrollment request for one student; rescind the motion made at May's meeting accepting the resignation of Dan Painter, and accept his contract for 2014-15; approve contracts with Kim Sogn-Community Education Director, Jordan Hout-BBB Asst. Coach, Eric McGillvray-MS BBB and MS FB Coach, Lisa Priesz-Cheer Coach, Angela Sogn-Payroll Clerk, and Peggy Jimmerson- Title I Para-Professional; and approve membership for 2014-15 in the SD Unified School Association. Aye: all members

K. Jensen moved, second by B. Henke to approve the bills for payment. Aye: all members

T. Larson moved, second by T. Iverson to accept the financial statement for the month of June 2014. Aye: all members

Administrative reports were given and included the following: summer school, Spire and Edgenuity training, 2014-15 course offerings and tentative schedule, food service participation and profit/loss for 2013-14, a review of the 2013-14 budget compared to actual totals, and the year end school vehicle report.

At 8:00 pm the annual Proposed Budget Hearing for the 2014-15 school year was conducted. The board reviewed the proposed budget and supporting documentation. The 2014-15 budget will be adopted at a later date.

Bids for the Armory roof were received as follows:

Single Ply Roof, re-cover only: ARS Roofing \$100,615.; Boone Bros \$115,445.; Guarantee Roofing \$69,904.
Single Ply Roof, Complete new roof: ARS Roofing \$131,240.; Boone Bros \$163,025.; Guarantee Roofing \$102,104.
Steel Roof: Boone Bros \$197,800.; Modern Builders \$156,600.

Contractors reviewed the pros and cons of each type of installation. After much discussion, the following motion was made:

7/1/14 T. Iverson moved to accept the steel bid from Modern Builders for \$156,600. K. Jensen moved, second by B. Henke to amend the motion to include "contingent upon the structural engineer signing of on the projected drainage report". Aye: all members to approve the amendment. K. Jensen seconded the motion as amended.

The board discussed filling the board position currently held by Craig Stearns.

7/2/14 T. Larson moved, second by B. Henke to appoint Craig Stearns as board member for one year to fill the position. Aye: all members

The Board discussed renewal of the CTE Academy five year contract. Action was tabled for the August meeting.

The Board conducted the first reading of proposed policy changes.

The regular meeting was adjourned at 10:00. The Board reconvened for the annual meeting of the Canton Board of Education. The meeting was turned over to the Business Manager.

The Oath of Office was signed by returning board member Kevin Jensen for a three year term, and appointed member Craig Stearns for a one year term.

Craig Stearns was re-elected Chairman of the Board of Education. The meeting was turned over to the Board Chairman.

Kevin Jensen was re-elected as Vice-Chairman of the Board.

 - d. Designate the vice-chair to countersign checks in the Chairman's absence
 - e. Designate Terry Gerber and Nancy Thompson as authorized representatives for all Federal and State Programs, including the Food Service Program
 - f. Appoint Rodney Freeman as the school attorney as needed
 - g. Authorize Terry Gerber or his designee to close school in case of inclement weather or other emergencies
 - h. Authorize Nancy Thompson as custodian of all accounts, and to transfer money as needed
 - i. Authorize Nancy Thompson to act as purchasing agent
 - j. Appoint Terry Gerber or his alternate to the Advisory Board of the SE Area Cooperative
 - k. Advertise for bids on diesel/gas for the 2014-15 school year
 - l. set admission prices for events and activity tickets (same as prior year)
 - students \$2.00, \$3.00 for basketball doubleheaders, \$25.00 activity ticket
 - adults \$4.00, \$5.00 for basketball doubleheaders, \$40.00 activity ticket
 - family activity ticket \$130.00, golden age passes are available for senior citizens over 62
 - middle school tournament and track meets, \$2.00 adult and \$1.00 student
 - m. set lunch prices (same as prior year)
 - K-5: lunch \$2.05, breakfast \$1.40
 - 6-12: lunch \$2.15, breakfast \$1.40
 - Reduced price lunch 40 cents, and reduced price breakfast 30 cents
 - Adult lunch \$3.30 and adult breakfast \$1.65
 - n. set substitute pay rates the same as last year, teachers \$95. Per day, day 11 and longer in the same classroom at \$105; paraprofessional aides at \$9.50 an hour, unless substituting to work with a special needs student, the rate will be \$11.00 an hour
